The Talmudical Yeshiva of Philadelphia is a post-secondary school eligible to receive funds from Title IV. We have received \$111069.00 under Section 18001 (a) (1) of the Cares Act to provide emergency financial aid grants to students as of July 8, 2020. We have signed and returned the certification and Agreement to the Department of Education stating that we intend to distribute no less than 50% of these funds to the students. There were 103 students eligible to receive these funds.

As of today, the Yeshiva has allocated \$52,530 in the form of \$510 to 103 students. In addition, the Yeshiva has allocated \$3629.70 to 10 students for travel expenses exceeding \$100, for a total of \$56159.70.

The Talmudical Yeshiva of Philadelphia made a calculation of expenses that students may have incurred due to the disruption of campus operations caused by Covid-19, including things like course materials and technology as well as food, housing and health care. We felt it was an equitable expense for all students.

Following is the letter we have distributed to our students along with their check.

Dear XXX,

We are pleased to inform you that you have been awarded an Emergency Financial Aid Grant from the portion of funds allocated to our institution through the CARES Act Higher Education Emergency Relief Fund which provides funding to institutions to provide emergency financial aid grants to students.

Enclosed please find a check in the amount of \$XXX which, is the amount that our school has determined as the amount of the grant, based on the number of qualifying students, the allocation given to the school for its students and a calculation of expenses that students may have incurred due to the disruption of campus operations caused by COVID-19.

As per the CARES Act, these grants are to be used for expenses that are related to the disruption of campus operations due to COVID-19, including things like course materials and technology as well as food, technology, housing and health care.

As per guidance recently issued by the IRS, these grants are not taxable.

The Talmudical Yeshiva of Philadelphia is a post-secondary school eligible to receive funds from Title IV. We have received \$156,402.00 for the CRRSAA grant under Section 314 (a) (1). \$100,868 was distributed to 129 students to provide emergency financial aid grants as of March 22, 2021. Each student received a minimum of \$650, and students with greater financial need received more funds on a sliding scale, for a maximum grant of \$954. The students received the above letter with this grant as well.

The institutional portion of this grant of \$55,534, together with the remaining \$54,909.30 of the Cares Act funds, has been allocated as a scholarship for needy students. 54 students received a Covid scholarship of \$2000, and one particularly needy student received \$2444.30.

The Talmudical Yeshiva of Philadelphia is a post-secondary school eligible to receive funds from Title IV. We have received an additional \$161,288.00 on May 20, 2021 under Section 18001 (a) (1) of the Cares Act to provide emergency financial aid grants to students. There were 114 students eligible to receive these funds.

Each student received a minimum of \$700, and students with greater financial need received more funds on a sliding scale, for a maximum grant of \$1000. The students received the above letter with this grant as well.

The Talmudical Yeshiva of Philadelphia is a post-secondary school eligible to receive funds from Title IV. We have received \$377,740, award #P425N200735 in FIPSE Funds. The funds have been disbursed as follows:

Due to the uncertainty of the times, any student who was not PELL eligible had their tuition raised by a maximum of \$6000. Since many of the students were not able to afford this increase, the covid funds were used to cover this shortfall.	\$225,474

The Talmudical Yeshiva of Philadelphia is a post-secondary school eligible to receive funds from Title IV. We have received a total of \$272,358.00 under Section 18001 (a) (1) of the Cares Act to provide emergency financial aid grants to students. As of September 2022, we were left with \$63,788 to disburse. We also received \$317,689 in institutional funds, of which, as of September 2022, \$161,287 remained. We have disbursed \$103,200 in emergency aid, using the remaining \$63,788 from Grant P425E205021, along with \$39,412 from Grant P425F204290.

There were 120 students eligible to receive these funds.

Each student received a minimum of \$700, and students with greater financial need received more funds on a sliding scale, for a maximum grant of \$1000. The students received the above letter with this grant as well.

The Talmudical Yeshiva of Philadelphia is a post-secondary school eligible to receive funds from Title IV. We have received a total of \$272,358.00 under Section 18001 (a) (1) of the Cares Act to provide emergency financial aid grants to students. As of April 2023, we were left with \$121,875 to disburse from Grant P425F204290.

There were 118 students eligible to receive these funds.

Each student received a minimum of \$745, and students with greater financial need received more funds on a sliding scale, for a maximum grant of \$1300. However, one particularly needy student received \$1410.

The students received the above letter with this grant as well.
